FUNCTION TERMS & CONDITIONS

Types of Functions:

Chasers Function Centre is available for most types of functions however Chasers does <u>not</u> cater for 18th Birthday Parties.

Hire fee:

Chasers Function Centre is available for hire at a cost of \$330 (including GST) as well as a refundable deposit of \$250 that is returned within seven days of the function should there be no damage to the property and fittings during the function.

Confirmation & deposit:

The hirer is requested to confirm booking in writing using the function booking sheet. The function will be confirmed once the hire fee of \$330 is received. The deposit of \$250 is required to be paid no later than seven days prior to the function.

Catering arrangements and payments:

The catering for functions at Chasers Function Centre is exclusively done by Goldfields Catering. Catering arrangement, requirements and payments are to be arranged between the hirer and Goldfields Catering and catering terms and conditions set down by Goldfields Catering will form part of the terms and conditions for any function at Chasers.

Cancellation:

Cancellation of a function by the hirer must be advised in writing. If the function is cancelled with less than 28 days notice then the hire fee will be forfeited by the hirer.

Insurance and Damages:

Chasers, and the Bendigo Greyhound Racing Association, cannot take responsibility for damage to, or loss of items before, during and after a function, it is recommend that you arrange appropriate insurance cover if required. Please note, you are financially responsible for any damages sustained to Chasers (and the BGRA) property and fittings during the function. No attachments are to be used on the walls without prior approval from management.

Payment for Beverages (if applicable):

For functions that are conducted under a dry till arrangement (i.e. guests do not pay for drinks/or certain types of drinks on the night) a minimum of 50% of the agreed amount being allocated for beverages is to be paid no less than 24 hours prior to the commencement of the function unless otherwise agreed prior.

The balance of the beverage account is to be paid at the completion of the function or on account, depending on arrangements made at the time of booking. It should be noted that Chasers is a licensed venue with strictly no BYO.

Security:

For certain types of functions licensed security personnel is required, with the cost to be the responsibility of the hirer. Such functions include 21st Birthday Parties and sporting club functions as well as functions in excess of a certain number of guests - unless otherwise agreed prior.

Surcharges:

Please note that a surcharge of \$330 (incl GST) will be applicable to functions on Sundays or Public Holidays.
